## 2023 Craft Fair Maker/Crafter Regulations

The store, Fabricated For You, located at 1081 RT 37 in Toms River NJ will be referred to as "The Store" below. All applicants who will be selling goods at our event, inclusive of any vendors, crafters, whether be individual or business, will be collectively referred to as "Makers" below.

### **Maker Regulations:**

- 1- Items for Sale:** Makers must be selling handmade items, no purchase and resell items are allowed. If purchased items are used in your handmade item, this is ok, but all your items must be hand or selfmade. After approval, if any resale items are found within your table or booth, they will be asked to be removed.
- 2- Maker Approvals:** Makers will be approved prior to the event, and there is a chance your application can be denied if there is not enough space available. Applications will be accepted on a first come basis. In the event your application is denied, all application fees will be promptly refunded. Photos or links to products will be requested with your application.
- 3- Maker Setup:** Makers arrive with enough time to set up their table or booth to be completed a minimum of a half an hour before the event start time. Although you can continue setting up, cars must be moved and parked in the designated Maker parking area a minimum of a full hour before the event start time. Any Makers with a space to set up inside the store must be completed with their entire setup by the opening time of the store. Please see store hours if this applies to you.
- 4- Space Provided:** If needed, Makers must provide their own tent, table, and chairs. There will not be any extras available to provide to Makers. All Makers will be provided with a space that is selected at time of application. Makers cannot exceed their designated space, and must leave a minimum of 1' clearance on all sides of their space. Space sizes are first come first serve basis. After applying and selecting your space size, you will be assigned a space upon approval. If you are unable to get the space initially requested, a new size will be assigned. If you cannot use the size space assigned, please contact and if no resolution is available we will provide a full refund.
- 5- Break down:** Makers cannot dismantle their displays prior to the end of the event. No Maker vehicles will be allowed to be brought into the lot areas until the conclusion of the event, or when all patrons have exited the Maker areas, whichever is later.
- 6- Maker liability:** Makers cannot combine to share space, nor sublet their entire or part of their space. Makers are responsible for all of their own products, and should make their own efforts to protect from theft, or

mother nature. The store will not be responsible for any Maker products, or personal property / losses or injuries. You are advised, but not required to carry your own insurance. SpecialEventInsurance.com has plans that start at \$50 per year and can cover all events you attend. I agree to indemnify and defend The store against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my use of or presence upon the facilities of The store. I agree to pay for all damages to the facilities of The store, or other makers, caused by any negligent, reckless, or willful actions by my party.

7- Restrictions:

"Weapons" - No form of weapons may be displayed, inclusive of guns, knives, swords, tasers, and any other item that is normally considered a weapon and can cause harm.

"Food and Drink"- No food or beverages can be served or for sale without prior approval from the store.

"Trademarks"- Illegal, copyright, and trademarked items are not allowed and It is a Maker's responsibility to know if they are selling trademarked items or are in violation of any trademarks. The store cannot determine if your products are ok or "legal" to sell.

"State regulations"- It is a Maker's responsibility to collect and file and sales tax necessary, if need be. It is also a Maker's responsibility to know if they qualify for and are required to display a Sales and Use tax certificate.

"Refunds"- Refunds will only be provided in the following scenarios: 1- A space size required is not available. 2- Application is denied prior to the event. Refunds will not be given for any other reasons. Once you are accepted to the event, your application is final. Denied applications that may occur the day of the event due to not following guidelines will not be refunded. Returned checks or credit charges will result in a dispute fee in the amount of \$50 in addition to any fees you were obligated to pay for the event.
