Must be returned to the store 10 days prior to the event date or space will be forfeited with no refund.

The store, Fabricated For You, located at 1081 RT 37 in Toms River NJ will be referred to as "The Store" below. All applicants who will be selling goods at our event, inclusive of any vendors, crafters, whether be individual or business, will be collectively referred to as "Makers" below.

**Maker Regulations:**

- 1- Items for Sale: Makers must be selling handmade items, no purchase and resell items are allowed. If purchased items are used in your handmade item, this is ok. Any resale items are found will be asked to be removed.
- 2- Maker Approvals: There is a chance your application can be denied. Applications will be accepted on a first come basis. In the event your application is denied, all application fees will be refunded.
- 3- Restricted Categories: To keep the event fair to all, we restrict the amount of vendors selling certain items. This is selected when you register. You CANNOT sell items from a restricted category unless you selected this category during registration. If you bring Restricted items, you will not be allowed to display them the day of the event.

Anyone MAY sell items from a "MOSTLY" category, but vendors selling MOSTLY those items must select that category.

*RESTRICTED categories: Tumblers - Crochet Animals - Framed Sea Glass - 3D Printed Toys/Fidgets*

*MOSTLY categories: Knit items - Candles/Melts - Soaps - Holistic - Paintings - Paddle Signs - Tall Welcome Signs - Handsewn Clothing items - Signs - Jewelry - T-shirts/Clothing - Wreaths*

**You must be registered in a restricted category to sell ANY items from a restricted category.**

4- Rain Dates: Please be sure you are available for rain dates, as refunds will be unavailable. In the event a rain date is also rained out, if vendors are unable to attend the newly proposed date, they will be credited for a future event.

5- Maker Setup: **Tents are required to have weights on all 4 poles. You will be asked to remove unweighted tents. Tents and all tables/displays MUST be within your marked space.** Makers setup to be completed a minimum of a half

an hour before the event start time. We allow vehicle-to-space drop off, but this ENDS at 8am. Makers will then need to carry items from the parking lot to their space, approximately 60-100ft depending on space location.

6- Space Provided: If needed, Makers must provide their own tent, table, and chairs. Makers cannot exceed their designated space, and must leave a minimum of 1' clearance on all sides outside of their space.

7- Break down: Makers cannot START to dismantle their displays prior to the end of the event. Starting to clean up/breakdown prior to 4pm forfeits your ability to attend future events. There are absolutely no exceptions to this. If you cannot stay until the end of the event, please do not register. No Maker vehicles will be allowed to be brought into the lot areas until vendor tents are dismantled allowing access. You are welcome to carry items out to your car prior to vehicle access being allowed.

8- Maker liability: Makers cannot combine to share space in booths smaller than 10x20, nor sublet their entire or part of their space. Makers are responsible for all of their own products, and should make their own efforts to protect from theft, or mother nature. The store will not be responsible for any Maker products, or personal property / losses or injuries. You are advised, but not required to carry your own insurance. SpecialEventInsurance.com has plans that start at \$50 per year and can cover all events you attend. I agree to indemnify and defend The store against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my use of or presence upon the facilities of The store. I agree to pay for all damages to the facilities of The store, or other makers, caused by any negligent, reckless, or willful actions by my party.

9- Prohibited Items:

"Weapons" - No form of weapons may be displayed, inclusive of guns, knives, swords, tasers, and any other item that is normally considered a weapon and can cause harm.

"Food and Drink"- No food or beverages can be served or offered for sale without prior approval from the store.

"Trademarks"- Illegal, copyright, and trademarked items are not allowed and It is a Maker's responsibility to know if they are selling trademarked items or are in violation of any trademarks. The store cannot determine if your products are ok or "legal" to sell.

"State regulations"- It is a Maker's responsibility to collect and file and sales tax, if need be. It is also a Maker's responsibility to know if they qualify for and are required to display a Sales and Use tax certificate.

"Refunds"- Refunds will only be provided in the following scenarios: (1- A space size required is not available. 2- Application is denied prior to the event.) Refunds will not be given for any other reasons. Once you are accepted to the event, your application is final. Removed makers on the day of the event due to not following guidelines will not be refunded. Returned checks or credit charges will result in a dispute fee in the amount of \$80 in addition to any fees you were obligated to pay for the event.
